FEE AGREEMENT & POLICY 2022

School and Kindergarten fees are used in conjunction with Commonwealth and State funding to provide high quality art and learning resources, as well as exceptional adult to child classroom ratios to support children in their learning at Maridahdi. Maridahdi endeavours to keep fees as low as possible so that our ethos is accessible for all. However to support this, we rely on day-to-day parent involvement in the Kindergarten and School, and in community maintaining the grounds and buildings: see the Maridahdi Enrolment Process and Policy for an outline of parent contributions required at Maridahdi.

In 2022, Maridahdi Early Childhood Community School and Kindergarten Tuition Fees are as follows:

	Per Term	Annual Fee
Kindergarten	\$970	\$3880
School	\$1430	\$5720

Due Dates are advised on the accounts provided to parents and are generally due before that term commences.

Building Fund: We request that families consider contributing \$100 per term to the Maridahdi Brisbane Primary School Building Fund. These optional contributions are directed towards the acquisition, construction or maintenance of school buildings. Payments made to this fund are tax-deductible.

Fundraising Levy: An optional contribution of \$50 charged per term per family in lieu of an expectation that Maridahdi community members contribute to fundraising efforts.



FEE AGREEMENT & POLICY 2022

KINDERGARTEN

Enrolment Application Processing Fee: \$150 for first application, \$50 for every subsequent sibling application (non-refundable).

Enrolment Fee: \$200 paid as acceptance of 2022 Kindergarten or School position offered. Unlike the previous Enrolment Bond, this amount is non-refundable.

Discounts:

A 5% discount on tuition fees is available if paying a student's annual tuition fee upfront by the Term 1 invoice due date

At any one time, when a family has, at the School:

- One child enrolled: 100% of tuition fees are payable;
- Two children simultaneously enrolled: 100% of tuition fees payable for one child and 85% of tuition fees payable for other child (equating to a 15% discount for the second child).
- Three (or more) children simultaneously enrolled: 100% of tuition fees payable for one child, 85% of tuition fees payable for second child and 70% of tuition fees payable for third (or more) child enrolled (equating to a 30% discount for the third (or more) child).

These discounts are subject to annual review and fees being paid up to date and in advance.

Maridahdi Community Governing Council financial membership: Nominal fee per adult (determined pre-AGM annually), payable as directed. Financial members may stand for election and vote at the Annual General Meeting (AGM) and other Special Meetings (as called). The AGM is held in Term 1 or Term 2 of a school year.

Excursions: Families will be advised of any excursion costs in advance of the planned event.

Maridahdi Fee Policy:

- 1. Fees detailed are effective from 15 September 2021 and shall remain in force until such time as changed by the Maridahdi Community Governing Council (the 'Governing Council'.)
- 2. Whilst it is the general practice of the Governing Council to review and set fees on an annual basis, the Governing Council reserves the right to change these fees at any time.
- 3. As outlined in the Maridahdi Fee Agreement, fees fall due at the beginning of the period they cover and are payable in advance of the term they cover.
- 4. Please contact the School for advice in the event that you are unable to pay the fees by the due date.

 Please note that a Payment Plan will only be considered in situations where a term has been paid in advance and is subject to approval by the Principal and/or Business Manager.
- 5. In the regrettable situation where fees are unpaid at the due date and/or agreed arrangements are not being maintained, or after repeated failure to meet the negotiated payment schedules then the Kindergarten or School may:
- a. apply an administrative fee of 5% interest per term to the outstanding balance of tuition fees from that point on;
 - b. reverse any discounts or reductions in fees;
 - c. direct unpaid accounts to a Collection Agency and/or take legal action; and/or
- d. terminate the enrolment of the student(s) to whom this point applies. Due to our whole family approach as outlined in the Maridahdi Enrolment Policy, this may mean all students from a family may have their enrolment terminated.
- 6. At least one term's written notice (10 weeks) of withdrawing a student from the Kindergarten or School is required. If inadequate notice is given, a term's fees will be payable. Students finishing Year 6 at the end of Term 4 in their last year are exempt from this requirement.
